Inspector Greg Ovanessian Retires

Friend, colleague, and elder advocate Inspector Greg Ovanessian is retiring from a long career in the San Francisco Police Department's Economic Crimes Unit. Ovanessian is well respected by his peers and the elder justice community who will miss insight and experience in the field.

Joint Accounts and the Elderly

Paula Span, a *New York Times* blogger, "The New Old Age", and author who writes about issues affecting the elderly, interviewed the director of the American Bar Association's Commission on Law and Aging, Charles Sabatino, who suggests that joint bank accounts still leave the senior vulnerable to financial exploitation. Instead, Sabatono recommends what banks call "convenience" accounts, which still permit the senior's relative or other designated agent to pay the bills, but this account also invests the agent with responsibility to serve the interests of the senior. No right of survivorship exists after the main account holder dies and while these accounts are not monitored, they nonetheless indicate intention in a clear, transparent manner.

Fraud and Scam Alerts

Lottery Scammers Now Misusing Public Services - From <u>www.Scamnot.org</u>

The IC3 (Internet Crime Complaint Center) has received several complaints from victims who reported receiving telephone



and other handling fees, to collect the lottery winnings. The subject threatened many victims with physical violence if they refused to wire money. The subjects were identified as Jamaican through their accents and verification of numbers displayed on the victim's caller ID.

Though this scam is not new, the subjects continue to develop new methods to further their fraudulent scheme. After the victim's family realized she was a victim of fraud and interceded to stop the liquidation of the victim's funds, the subject sent a taxicab to take the victim to a major retail establishment that offered wire transfer services, hoping the victim would wire the funds as requested.

In other instances, after elderly victims realized they were being defrauded and stopped participating in the lottery scam, the subjects asked local law enforcement to conduct "well-being" checks on the victims. However, during the courtesy checks, the victims told law enforcement about the lottery scams and avoided further victimization. Apparently, the fraudsters tried to use law enforcement to further coerce the victims into again communicating with, or sending funds to, the fraudsters.

Department of the Treasury Financial Crimes Enforcement Network Advisory FIN-2011-A003 Issued: February 22, 2011



Subject: Department of the Treasury Advisory to Financial Institutions on Filing Suspicious Activity Reports Regarding Elder Financial Exploitation

The Financial Crimes Enforcement Network (FinCEN) is issuing this advisory to assist the financial industry in reporting instances of financial exploitation of the elderly, a form of elder abuse. Financial institutions can play a key role in addressing elder financial exploitation due to the nature of the client relationship. Often, financial institutions are quick to suspect elder financial exploitation based on bank personnel familiarity with their elderly customers. The valuable role financial institutions can play in alerting appropriate authorities to suspected elder financial exploitation has received increased attention at the state level; this focus is consistent with an upward trend at the federal level in Suspicious Activity Reports (SARs) describing instances of suspected elder financial exploitation. Analysis of SARs reporting elder financial exploitation can provide critical information about specific frauds and potential trends, and can highlight abuses perpetrated against the elderly.

This advisory contains examples of "red flags" based on activity identified by various state and federal agencies and provides a common narrative term that will assist law enforcement in better identifying suspected cases of financial exploitation of the elderly reported in SARs.

Stamp Out Elder Abuse Initiative Launched

This new initiative was launched by Elder Financial Protection Network (EFPN), the Elder Justice Coalition, Tennessee Vulnerable Adult Coalition and the Tennessee Commission on Aging and Disability. As part of the initiative, a proclamation was announced at the recent Elder Financial Protection Network's 8th Annual Call to Action on March 31. Elements of the proclamation include:

- We the citizens of the United States of America respectfully request that our President and Congress enact legislation that would authorize the United States Postmaster General to issue an Elder Abuse semi postal stamp; and,
- We call upon Congress to fund the Elder Justice Act of 2010.
- The citizens of the United States of America, respectfully urge the President to issue a proclamation recognizing June 15, 2011 as World Elder Abuse Awareness Day and consider lighting the White House Purple on this date.

SB 586 - Elder and Disabled Adult Abuse Prevention Act

Authored by State Senator Fran Pavley and sponsored by AARP, SB 586 increases the fines for elder abuse crimes (including fraud, forgery, theft, embezzlement, identity theft, and physical abuse) with monies dedicated to the Adult Protective Services Agency in the jurisdiction where the crime is prosecuted. Monies would be for the purpose of abuse prevention and investigation. An additional provision of the bill seeks to prevent financial abuse of California's elderly and disabled population by defining and regulating the issuance of "signature stamps" by financial institutions. This would include establishing a framework in the financial code for the prevention of fraudulent signature stamp use.

Assemblymember Yamada Introduces Eight-Bill Aging and Long-Term Care Package

In February, Assemblymember Mariko Yamada, chair of the State Assembly's Aging and Long-Term Care Committee introduced a series of bills to improve services to older adults in California. The package included a bill to enhance elder abuse reporting requirements (AB 40) and a bill to assure flow of OAA dollars to Area Agencies on Aging during state budget standoffs (AB 533).

Obama Budget for FY 2012 Includes Elder Justice Act Funding In their February 14, 2011 newsletter, the Elder Justice Coalition (EJC) announced that President Obama's FY 2012 budget proposed more than \$20 million in first time funding for programs included in the Elder Justice Act of 2010. The funding breakdown is as follows:

- Adult Protective Services (APS)-\$16.5 million for State Adult Protective Services demonstrations to improve operations. Of these funds, \$1.5 million will be targeted for coalition building, training and technical assistance, elder rights program development and research for preventing and addressing elder abuse within Tribal nations according to the Administration on Aging (AoA).
- Long-term Care Ombudsman Program-an additional \$5 million to improve resident advocacy to elders and adults with disabilities who live in long-term care settings.

The Professional Fiduciaries Bureau

The Professional Fiduciaries Bureau was created by legislation that passed and was enacted into law in 2007 to regulate non-family member professional fiduciaries, including conservators, guardians, trustees, and agents under durable power of attorney as defined by the Professional Fiduciaries Act.

Professional fiduciaries provide critical services to seniors, disabled persons, and children. They manage matters for clients including daily care, housing and medical needs, and also offer financial management services ranging from basic bill paying to estate and investment management. Requirements for licensing include passing an examination and completing thirty (30) hours of approved education courses (See Pre-Licensing Education Information), and earning fifteen (15) hours of continuing education credit each year for renewal. Licensees must comply with reporting requirements and must abide by the Professional Fiduciaries Code of Ethics so that client matters are handled responsibly and without conflict.
