Keynote speaker:

Marie-Therese Connolly, recipient of a MacArthur "Genius" Award for her national leadership in combating elder abuse, is a senior scholar at the Woodrow Wilson International Center for Scholars. She was formerly director of the U.S. Department of Justice's Elder Justice and Nursing Home Initiative where she developed new theories of liability and novel investigation and litigation strategies that led to successful prosecution of cases of abuse and neglect in nursing homes. She was also instrumental in the drafting and passage of the Elder Justice Act. She worked to bring together various stakeholders in the elder justice field — including researchers, law enforcement officials, social workers, advocates, legislators, and clinicians — to identify gaps in current legislation and develop a comprehensive policy strategy. She is continuing this work as founder and director of the Life Long Justice initiative, where she is creating an integrated national advocacy effort to prevent, detect, and intervene in the mistreatment of the elderly. Connolly received a BA from Stanford University and a JD from Northeastern University School of Law.
